State of Transfer: California State University

- ❑ Two Transfer Pathways:
 - A) Traditional Pathway
 - B) ADT Pathway
- ❑ IMPACTION (LOCAL AREA)
- ❑ Transfer legislation that aims to improve transfer
- ❑ Grade Alleviation Reform



Pathway # 1 vs Pathway # 2

TRADITIONAL

- ❑ Minimum CSU admissions requirements
- ❑ Drawback: need to research LD major requirements on CSU's respective websites (screening campuses) - ASSIST.org to match courses with CC courses
- ❑ Flexibility: CSU's accepting LD students and full GE certification is not required for admission

ADT

- ❑ One common list of LD major requirements
- ❑ .1 bump in GPA for admission purposes
- ❑ Guarantee into at least one CSU campus
- ❑ Guarantee to graduate within 60 units upon transfer
- ❑ GE pattern is required to earn ADT

Transfer Initiatives & Legislation attempt to addresses transfer access

- CCC Chancellor's Office Vision for Success and Vision 2030
- AB 928 - Berman. Student Transfer Achievement Reform Act of 2021
 - CalGETC - 1 lower division GE transfer pattern
 - Auto ADT Enroll
- AB 1111 - Berman. Postsecondary education
 - Common Course Numbering System

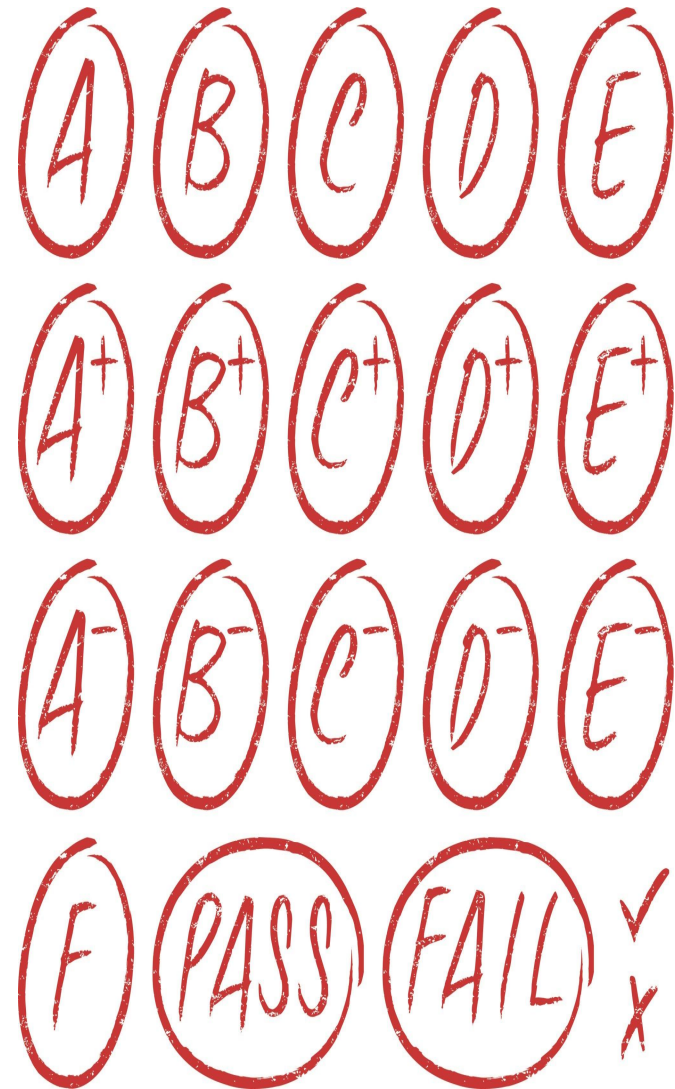


IMPACTION (Local Area Declared)

- ❖ CSU's that receive more transfer applications than can be admitted declared a "local area"
- ❖ Impacted campuses: **Fullerton, Long Beach, San Diego, San Jose, Fresno and San Luis Obispo**
- ❖ Typically require higher grade point averages for out of area students
- ❖ "local" defined by where students earned most units (local CC's) except:
 - SLO: considers local high school districts
 - CSU Long Beach: considers local high school districts AND local CC's
- ❖ Myth: all impacted campuses screen for major prep for admission
 - CSU Fullerton and Fresno State do not screen for major prep (exception: AJ major requires one major prep course for CSUF)

CSU GRADE ALLEVIATION REFORM

- ❖ CSU system averages out two attempts of same course if taken at two different CC's
- ❖ CSU system requires that CC where student earned a substandard grade is noted with alleviation notation if course is repeated successfully at different CC
- ❖ The committee's goal is to reform the Academic Renewal Policy (statewide)
- ❖ The committee has presented on this issue at FACCC's Advocacy & Policy Conference (Spring 2024) and at an Academic Senate Plenary Session (Fall 2024)
- ❖ Academic Renewal Task Force via California Community Colleges Chancellor's Office to adopt Title V revisions (chaired by assistant Vice Chancellor)



FACCC Counselors Committee Recommendation for Practice: (Based on Los Angeles CCD Requirements for Academic Renewal)

- Completed credit coursework at a United States regionally accredited institution(s), since the term of the coursework to be disregarded, as follows:
 - Minimum of the equivalent of 12 semester units with a 2.0 cumulative GPA
 - At least one (1) academic term (fall, winter, spring, summer) must have passed since the term when the coursework to be disregarded was completed.
- Multiple petitions allowed; up 30 units max.

FACCC Counselor Committee Future Goals

- Advocate for practitioner-based transfer legislation
- Help facilitate equitable transfer practices and policies
- Continue working with Chancellor's Office Academic Senate to change Title V
- Collaborate with intersegmental partners to advocate for equitable admission practices
 - ◆ Comprehensive Review (Pilot CSU: Cal Poly Pomona)
 - ◆ GPA calculation policies
