- President's Report Wendy Brill-Wynkoop  
Continuing to advocate for 1705; trying to move the needle forward. 50% Law advocacy.

#### Recognition of Outgoing Board Members

- Members of the Boards read statements in recognition for the three outgoing members of the Boards; Laura Alarcón, Andrew Walzer, and Desiree Montenegro.

#### Recommendations from Board Task Force - Wendy Brill-Wynkoop

- Suggested Bylaws amendments from the Board Task Force.
  - They considered the size of the Boards in the face of adding new contract schools, recommendations from PT Committee, and recommendations of the removal of the Regional Governor seats.
  - Board Task force unanimous in recommendation to remove regional seat.
  - Discussed At-Large seats and what it meant to be an at-large members. Keep six seats but have two seats each for small, medium, and large districts, and to have at-large seats open to FT and PT faculty. All officer positions are open to any current or previous member of the Boards.
  - This item will come back in June for second read.



Policy Paper - Oranit Limmaneeprasert

Oranit reported about possible policy papers.

50% Law Paper; add JLAC audit results to the draft and focus on how to move forward from where we are at now.

Evolving Mission of CCC; add repeatability, bring back life-long learning (CCCCO had Webinar about how to get adult learners back)

Role of CCCCCO; need focus on the industry relationships' influence through the Foundation

Issues

- Legislative Update Anna Mathews

Anna reported that our sponsored leg is doing well. Passed through Senate and will likely go to Assembly Higher Ed. AB271 PT health care bill still in the works. AB 65 paid parental leave might be too costly in year of bad budget. Webinar on AB1705 and 50% Laws and should be a May Revise one as well.

At one of the CCCO AB1705 sessions, the RP group started to present their data and then there was a ton of push back from the Math faculty. Resolution has been circulating and is being signed by many colleges' Senates.

Anna visited CCCI conference and had great conversations about Dual Enrollment and that information will be helpful in the few bills that are in the works.

PT faculty rights for termination AB1028 (Fong)

Berman bill regarding transfer AB934 sponsored by the Campaign. Retroactively award degrees and certs. Concern about financial aid being used where students did not desire. Bill heading to leg committee; need to negotiate with author so we don't have to take an oppose.

The Boards had a discussion about our priorities.

- State Budget and Audit Update Stephanie Goldman  
Budget advocacy on SCFF and universal COLA. May revise out soon.



Drafted letters for two separate audits. CCCI listed as primary sponsor on reserved audit. JLAC has asked some questions and Fraudulent enrollments audit still has time but has a lot of traction in the media. Might have a conversation with CCCCO about going forward.

May revise out next week; press release will be out in the following days.

- Concern/Complaint Process Oranit Limmaneeprasert  
Reviewed second draft of a complaint/concern form for submission. Discussed the draft form and took feedback.

#### Financial

- Treasurer's Report Mario Martinez

Mario presented a brief update of FACCC's financials for the 2024-25 fiscal year. Will likely hit our revenue goals though contract school are lagging in their payments. Release time bill is forgiven so that is additional savings.

New contract schools will provide additional support to the ongoing budget. The addition of two new years of the GTS contract with the state also helps in the short term.
