Updates:

- Sponsored/Co-Sponsored Legislation
 - AB 65 made it out of Appropriations
 - AB 1165 - nothing until January as a 2-year bill
 - SB 241 - AI bill has no fiscal impact, on its way to the Assembly
- Bills that made it out of the Appropriations Committee
 - 15/19 bills that FACCC is watching made it out of Approps
 - Supported bills held in Approps
 - AB 1035 - Promise grant for BA program
 - AB 240 - Study bill to increase access to rural colleges
 - AB 335 - Black Serving Institutions
 - Watched bills that were held
 - AB 934 - concerns, retroactive degree awarding, ed plans
 - AB 988 - Fong on Dual Enrollment Task Force
- State Budget
 - SB 101 - Budget bill, voted on this week
 - Prop 98 split will be protected in the bill, for this year, but anticipate it going forward next year
 - Legislator aligned with the Governor to redraw the ERP and the common cloud platform
 - Included PT office hours - \$48 million one-time money
 - \$50 million added for dream resource liaisons
- JLAC Audits
 - Go to the hearing on June 18

Discussion

- [AB 1705 CSU resolution update](#)
 - CSU Academic Senate - students have an understanding of their needs, and they should have the agency to enroll in prep courses.
 - Aligned with FACCC's advocacy
 - CSU - general lack of understanding that many HS students don't have access to or have taken Pre-Calc.
 - Think about advocacy and education for next year.
- [AB 1028](#) (Fong) Community colleges: temporary employees.

- **Position will remain a “watch”**
- [SB 226](#) (Cabaldon) Community colleges: territory transfers between districts) - Consideration FACCC’s change of position to “OPPOSE”, currently FACCC has a “WATCH”
 - The committee motioned and approved to oppose this bill
- Universal COLA - Update
 - Still advocating for Universal COLA for districts.
- Ideas for ethics/ honesty in reporting legislation or requests to CCCCCO
 - Possible bill proposal for next year
 - Enrollment data needs to be included.
 - Discuss the accounting practices used at the districts and request additional information.
