3.02 Survey Results --10:10 a.m.-10:15 p.m.

Key points:

1,165 PTers surveyed:

32% have taught for 21 years or more

6.7% have taught for five years or less

45% have taught between 6-15 years

44% had received some form of Public Assistance

80% thought they did NOT have a chance for a FT position.

Results were discussed.
